Schedule & Guidelines for Admission to Diploma Level Courses in Special Education and Disability Rehabilitation for the Academic Session 2020-21

National Board of Examination in Rehabilitation (NBER) an adjunct body of Rehabilitation Council of India (RCI) invites online applications from the eligible candidates for admission to its various Diploma Level Courses in Special Education and Disability Rehabilitation offered by RCI's approved Institutions/Universities Departments across the country through Online Centralized Admission process 2020. Admission to the above Diploma Level Courses will be made purely on merit basis through Online Centralized Admission Process 2020 for the academic session 2020-21.

Eligibility: 10+2 or its equivalent examination from a recognized Central/State Board of Education with minimum 50% marks aggregate. However, relaxation of marks at 10+2 level for students belonging to SC/ST/OBC/PwD category for admission to Diploma level courses will be applicable as per the reservation policy of the respective State/Central Govt.

Examination Fee:

- For General and OBC - Rs. 500/- (Five Hundred only) per candidate
- For SC, ST and PwD - Rs. 400/- (Four Hundred only) per candidate

Fee should be remitted through payment gateway by using a BHIM UPI App/Rupay Card/Debit Card/Net Banking/ Paytm/Card Credit issued by Banks in India. Fee once deposited will not be refunded under any circumstances.
